By-laws

Sadie Funk, Mary Warren, and Fran Jozefowicz drafted by-laws. That draft was shared with attorneys at Plunkett Cooney. Deborah Weatherston, Nichole Paradis, and Cathy Liesman have met with the attorneys to revise that draft. Attorneys' draft was written in response to new regulations for non-profit corporations. The current draft will be reviewed by MI-AIMH Executive Committee on December 11 then by the Alliance Planning Board in February or March of 2016. Plunkett Cooney is also filing articles of Incorporation for the Alliance.

Core Functions/Organizational Chart

This workgroup, that includes Susan Dickstein, Barry Wright, and Joy Browne, is working to conceptualize the work of the Alliance and a visual representation of the structure. Two drafts have been submitted to date. We anticipate working on another draft on November 8.

Infant Mental Health Home Visiting (IMHHV)

Pilots to evaluate the effectiveness of the two-generation IMHHV model have launched in multiple sites in Michigan. Faculty from the University of Michigan, Kate Rosenblum, PhD and Maria Muzik, MD, are the co-principal investigators.

Infant Mental Health Journal (IMHJ)

Beginning in January 2015, Paul Spicer, PhD became the Editor of the IMHJ. Therefore, the editorial offices moved to the campus of the University of Oklahoma. In 2015, IMHJ published a special issue on boys at risk. A conference to further discuss this topic is being co-sponsored by IMHJ in Santa Fe, New Mexico in November. Work is being done now for a 2016 special issue on reflective supervision/consultation with key Alliance leaders as authors.
